

## **MEDICAL SCREENING**

New international students are mandated to undergo the following medical screenings in accordance with the requirements of the Malaysian Ministry of Higher Education. In addition, the medical screening results shall be certified in accordance with the medical screening guidelines set by the Ministry.

### **PRE-ARRIVAL/OUT OF COUNTRY MEDICAL SCREENING**

1. As a new international student, you **must** attend a medical screening while you are still in your home country within 7 working days after offer letter was received. You will then be required to submit your pre-arrival health screening report together with all other relevant documents to the university.
2. If any of the pre-screening tests were positive, you need to inform University immediately for further instruction.
3. Please note that a valid yellow fever vaccination certificate is mandatory from all international students coming from or who have transited for more than 12 hours through countries with a risk of yellow fever transmission. Refer to Appendix A for List Of Countries At High Risk Of Yellow Fever Transmission.

### **IMPORTANT TO NOTE:**

University will not be able to process a VAL application in the event that the Out-of-Country (Pre-Arrival) medical screening report and the international certificate of vaccinations are not submitted by the candidates to University during the VAL application submission.

## **POST-ARRIVAL/IN-COUNTRY MEDICAL SCREENING**

1. New International Students
  - 1.1 New international students are required to attend a medical screening at the University Health Centre within 7 days of their arrival date.
  - 1.2 Bring along Checklist for New Student Registration that has been verified by Centre for International Affairs (CIA) and University Medical Examination Form for Post-Arrival Medical Screening at UniMAP Health Centre.

### **IMPORTANT TO NOTE:**

University will not be able to initiate the process of student pass endorsement and supporting letter issuance for sticker endorsement purposes in the event that the international students fail to undergo the in-country screening.

2. International Students applying for Pass Renewal
  - 2.1 International students who are renewing their student passes are not required to attend in-country medical screening.
3. International Students applying for Variation or Progression
  - 3.1 International students who are already in the country and applying to change their course or institution (Variation applications) and students who are progressing to a higher level of study (progression students) will be required to attend an in-country medical screening at UniMAP Health Centre if the last in-country medical screening was done more than 180 days from the date of applying for a new pass.
